



Bed Hold Policy & Agreement
Meadowbrook Health Center/Green House Homes

In the event that Meadowbrook Resident ("Resident") is temporarily transferred from Clark-Lindsey facilities to another location, and upon timely receipt of a written or verbal request from Resident or Responsible Party, Clark-Lindsey may hold Resident's accommodations open for up to 7 days from the date of transfer. A bed hold charge will apply while the Resident is out of the facility or residing in another bed within the facility. The bed hold rates are the same as the daily charged rates. (See attached rate sheet for applicable bed hold rates to be paid by Resident.)

If a written request for bed hold days is not received with 24 hours of the transfer, or a request to extend the bed hold is denied, then the Contract will be considered to have terminated. The Resident's property may be removed from the Resident's room and charges relating to the storage of resident's belongings will be the responsibility of Resident.

*Resident may request an extension of the bed hold beyond the 7 days and an extension of the bed hold may be granted at the sole discretion of Clark-Lindsey.

Skilled Care double-occupancy	\$310
Skilled Care single occupancy	\$ 435
Renewal single-occupancy	\$ 470
Green House Assisted Living	\$260/\$310
Green House Skilled Care	\$320

Bed hold rates are for when a person is out of the facility or residing on another unit and s/he chooses to hold his/her room during this time. Medicare and other third party payers will not pay for any bed hold charges. The resident is personally responsible for all bed hold charges.

*The Bed Hold Policy allows a resident to request a bed hold for up to 7 days. Requests for additional bed hold days must be approved by Administration. Extensions of the bed hold days are at the sole discretion of administration.

Note: Clark-Lindsey members, who have met their 5 year residency requirement, may be eligible for a member discount (as of January 1, 2019, this is equal to \$15/day).
